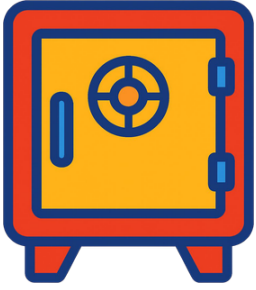

# Secure Firearm Storage

## Saves Lives

Responsible gun ownership is not just a matter of individual safety—it is critical to public safety. Ensuring firearms are stored securely reduces theft and prevents tragedies like unintentional shootings, mass shootings, and suicides. In a time when school shootings are a daily reality, it is critical that we take secure storage seriously.

## The Data

---

76% of school shooters receive their firearms from home or the home of a close relative.

In 2023, firearms claimed the lives of 4,651 Texans, including 276 children and teens.

Firearms are used in 62% of suicides in Texas. (2023)

Guns are the leading cause of death for children and teens in Texas and in the U.S. (2023)

# What Is the Law?

Thanks to the work of Texas Gun Sense and partners, Texas law requires school districts to share information about secure firearm storage to parents and guardians **at least 3 times per year.**

**2023**

House Bill 3 passed, requiring school districts to share information about secure firearm storage with parents and legal guardians.

**2025**

House Bill 121 passed, expanding HB 3 to require that school districts provide such information at least 3 times per year.



The Texas School Safety Center recommends districts provide information on secure firearm storage “at the beginning of the school year, before holidays and breaks, and at the end of the school year.”

# Action Needed

There are no enforcement mechanisms or guidance for school districts on how to fulfill these requirements, resulting in inconsistent compliance by school districts across Texas.

You can help make Texas schools and homes safer by working with your local school district to make sure parents and legal guardians are receiving secure firearm information in a clear and timely manner.

# How YOU Can Help

*Pro tip: language accessibility is critical to reaching all members of society. Make sure to consider sharing resources in both English and Spanish, and in any other relevant language.*
